

Naval Academy Chapel. An Irish wake followed at the Naval Academy Club with a robust "Celebration of Life.". Robert Tracey Sanders died 14 February 2020 after a long battle with Alzheimer's Disease. He was predeceased by his wife. His ashes will be interred in the Santa Fe, NM National Cemetery. There was no viewing or memorial service. He will be remembered by family during a Memorial Day event at the cemetery. Donations can be made to the Alzheimer's Association in Robert's memory. And in a follow-up to the death of Bob Cheek, Will Gabber has done a superb job of tracking progress on Bob's burial and composing an

obituary. Here is his input.

Robert Lewis Cheek, "Bob", died of complications of type two diabetes and heart disease on 4 October 2019 at his residence in Richmond VA. He was 75 years old. A native of the North Carolina Piedmont in the Kannapolis/ Salisbury area, he received a Congressional appointment from North Carolina. He was a National Merit Scholar. He entered the Naval Academy in June 1962, joining 1st Company and graduated from

Second Company. He was an exceptional math and science student, frequently helping others. He assisted the "Splinter" as layout editor.

Following completion of Nuclear Power and Submarine schools, he served on VON STEUBEN, (SSBN-632). He was on board during the incident with towed tanker SEALADY in August 1968. Bob briefly served at the Inactive Ship Maintenance Facility in San Diego. He left the active duty Navy in July 1970 and stayed in the Reserve until June 1976.

Settling in the Richmond VA area, he worked in the employee benefits field for a number of years. He switched to computer programming, earning two more BS degrees in programming and cyber security. He was a volunteer in the Big Brother, Big Sister Services company. A voracious reader, particularly science fiction, he stocked his residence with numerous books.

Bob never married and had no known surviving family. His younger brother, John Cheek, predeceased him in February 2019. A quiet individual, he requested no funeral or burial services. His ashes are interred in the Albert G Horton Jr. Veterans Memorial Cemetery in Suffolk VA. Thanks again to Will for helping the Class give a final, fitting tribute to Bob.

He has been published and appeared on national TV over 15 times based upon his investigative reporting, including testifying before Congress on veteran issues.

His topic was "How the Naval Academy Prepared Me for a Career As An Investigative Journalist -First, the Foundation; and then the Connections." His talk promises to be most interesting, as he knows many of our own Classmates, with whom he served while on active duty.

Captain George E. Wilson Jr., USN (Ret.), of Montgomery, AL, passed away on Tuesday, 5 March 2019. He was 76 years old.

George was born in Greenwood, MS, to Virgie Ellie Wilson and George Eugene Wilson and was preceded in death by them.

George, known as "Bullet," entered the Naval Academy after a year at Mississippi State. During First Class Year, he was in the 30th Company.

Bullet was a boxer, earned an "N," and took a brigade championship in his weight class.

A decorated 35-year Navy veteran, Captain Wilson received many awards and medals, including the Defense Superior Service Medal, Legion of Merit and Vietnam Service Medal with Bronze Star.

In his spare time and retirement years, George was an inexhaustible runner and won his age group many times. He was active in Frazer United Methodist Church, Good Morning Montgomery Kiwanis Club, the Military Officers Association of America and the U.S. Naval Academy Alumni Association. Since he was a child in Mississippi and through his final years, George absolutely loved the outdoors. He especially enjoyed hunting, fishing, bird watching, gardening and yard work; he thrived on experiencing and being a good steward to God's creation.

ROBERT TRACY SANDERS '66

Commander Robert T. Sanders, USN (Ret.), passed away on 14 February 2020 due to complications relating to Alzheimer's disease. He was 75 years old.

"Bob" grew up in Fairless Hills, PA, and attended Pennsbury High School (1959-1962). He played fullback on the football team and was also a three-year starter in wrestling, with an overall record of 54 wins, six losses and one tie. He won

32 dual meets in a row and was a District and Regional champion in 1961 and 1962. He was inducted into the Pennsbury School District Athletic Hall of Fame. At the Naval Academy, he wrestled all four years, with an exceedingly impressive record. In his Second Class (junior) Year, he placed third in the Eastern Collegiate Wrestling Association Tournament. As a Firstie (senior), he was ranked #2 nationally. Unfortunately, a severe knee injury kept him from finishing his undefeated season.

Upon graduation with the Class of 1966, Bob attended a Russian foreign language program and became a military intelligence officer, where he was

involved in classified special operations during the Vietnam War and the Cold War. He retired from the Navy in 1987 as a commander.

He went on to teach at the Montgomery County Community College in Maryland. Later, Bob and his wife, Marilyn, and their three children moved to Albuquerque, NM, where he taught math and science in Los Lunas Junior High School for ten years.

Bob was predeceased by his wife, Marilyn. He is survived by his brother, Roger Sanders; daughter, Jennifer; and stepsons, David and Christopher.

After being accepted to West Point and the United States Naval Academy, Duke chose USNA. There, among other things, he continued to play football. A member of the Eighth Company, Duke graduated with the Class of 1969 with a BS in Systems Engineering.

He married Linda Marie Musser on 25 April 1970. Duke received an honorable discharge from the Navy in 1974 as a lieutenant. For his 50th Naval Academy reunion, Duke wrote these poignant words, "My total commitment has been to God, Country and Family, since taking our oath in front of Bancroft Hall in 1965. In my mind, I have had a very successful, happy life. The key to that success has been the lynchpin that has helped me (and us) together through all the challenges and good times. That key has been and always will be, my wife, Linda."

Duke, always loyal and professional, worked for Liberty Mutual as a regional/divisional operations manager for 43 years, retiring in 2017. His most prized professional success was the building of honesty and integrity in the numerous teams he trained and worked with.

Weekends were spent at the gym, walking to the beach and watching sports, especially Navy football. Maui vacations were frequent.

JEFFREY ST. JOHN BALL '70

Jeffrey St. John Ball, 71, passed away at his home in Sarasota, FL, on 1 February 2019.

Jeffrey was born in New York, NY, during The Great Blizzard of 1947 on 27 December to Donald Thomas Ball and Ruth Catherine Murphy. A native of Port Jefferson, NY, he graduated from Port Jefferson High School (1966) prior to his appointment to the Naval Academy. With the Class of 1970, he graduated from USNA with a Bachelor of Science in Aerospace Engineering.

Following graduation, he reported to Naval Air Station Pensacola, FL, in pursuit of his Wings of Gold. He was selected to be a jet pilot and ultimately taught many aspiring naval officers to fly. After serving five years in the U.S. Navy as a lieutenant, he attended the Naval Postgraduate School (1975-1977), investigating naval aviation accidents.

Upon his honorable discharge from the Navy, he stayed in Monterey and flew for commercial airlines for a number of years before entering the commercial real estate world with industry leaders. After employment with J.R. Parrish, he went on to become the senior vice president of such prestigious companies as Cushman & Wakefield and Transwestern in northern California. Intent on establishing his own business, he founded Ball & Company Real Estate Advisors and was a member of the highly regarded Society of Industrial and Office Realtors. He achieved considerable success representing clients across the country.

He loved to share his passion for sailing, painting, drawing, Jeopardy! and board games such as Take Off! and Monopoly. Always the sports enthusiast, he played lacrosse, football and field handball during his time in Annapolis. He loved the Yankees, Jets and Giants and regularly attended Navy home football games. His first love, however, was flying, studying and appreciating aircraft. He had extensive knowledge on a wide variety of planes, especially those used in World War II and the ensuing

decades. Even the professors in his field of study at Annapolis were impressed with his knowledge. In addition, he had an extensive collection of authentic model airplanes and ships, many of which were replicas he built himself.

Jeffrey is survived by his wonderful children: daughters, Ashley, Whitney and Katherine; and son, Conor. He also leaves behind his siblings, Donna, Kim and Terry; and his loving partner, Lois McGovern.

Memorial services were held on 31 January 2020 at St. Andrews Chapel at the Naval Academy, followed by interment at the USNA Columbarium. ★



DANIEL TIMOTHY HOGAN '70

Commander Daniel T. Hogan, USN (Ret.), succumbed to metastatic colon cancer on 9 October 2019 at St. Louis Park, MN. He was 71 years old.

A native of St. Louis, MO, he entered the Naval Academy in the summer of 1966. Following graduation with the Class of 1970, 21st Company, with a degree in aerospace engineering, he entered flight training and was designated a

Naval Flight Officer in 1971. He flew EKA-3B Skywarriors with Tactical Electronic Warfare Squadron One Three Zero (VAQ-130) from MIDWAY, completing 175 combat missions in Southeast Asia. He transitioned to the EA-6B Prowler in 1974, deploying to WestPac with VAQ-135 onboard RANGER. In 1976, he reported to the Electronic Warfare and Reconnaissance Branch of the Strike Aircraft Test Directorate, Naval Air Test Center, Patuxent River, MD, as a flight test officer and held the position of EA-6B Flight Test Program Manager. While at Pax River, he earned a master's degree in Systems Management from USC. In 1979, he returned to sea duty flying EA-6Bs with VAQ-134 from the deck of NIMITZ.

In 1981, he undertook postgraduate study at the Naval Postgraduate School, Monterey, CA, and earned a master's degree in Aeronautical Engineering. In 1983, he returned to the Academy, where he assumed responsibility for coordinating the Core Electrical Engineering Curriculum. In 1986, he was designated a Materiel Acquisition Professional and was assigned to the Reconnaissance Electronic Warfare Systems Office, Naval Air Systems Command as Deputy Program Manager for Support Jamming Systems. In 1989, he was assigned as Commander, Defense Plant Representative Office, FMC, Minneapolis. He retired from naval service in June 1993.

Among his military decorations are the Defense Superior Service Medal, the Air Medal (with Bronze Star and seven strike/flight awards) and three Navy Commendation Medals with Combat V.

Following his naval career, he was Manager of Purchasing and Sourcing and Director, NAFTA Supply Operations for Buhler Inc, Minneapolis, an affiliate of Buhler AG, Switzerland. Upon leaving Buhler, he scored his dream retirement position as assistant operations manager at the golf course adjacent to his home on Annapolis Lane in Plymouth, MN, and enjoyed many hours of free golf with friends.

He is survived by his wife of 35 years, the former Laura Kay Wacher Brown of Akron, OH; sons, John and James (and his wife, Amy); daughter, Janelle (and her partner, Tyler); and namesake grandson, "Mini Dan."
